### **Crynodeb Gweithredol:**

Cysylltodd prosiect 'Kicks' Uwch-gynghair Clwb Pêl Droed Dinas Abertawe ag URS Sir Benfro er mwyn datblygu'r prosiect 'Kicks' yn Sir Benfro, mewn partneriaeth â'r Heddlu a SCHTh. Bydd y prosiect yn cyflwyno'r Prosiect 'Kicks' Uwch-gynghair i Sir Benfro, gan adeiladu ar y llwyddiant a gyflawnwyd yng Nglan-y-môr, Llanelli ac ar draws rhanbarth Dinas Abertawe. Bydd y prosiect yn rhoi cyfle i blant o'r ardal leol fod yn rhan o rywbeth ystyrlon – gan wella eu hyder a'u cyfleoedd bywyd, a gweithredu fel atalydd rhag trosedd ac ymddygiad gwrthgymdeithasol drwy chwaraeon. Bydd yn arddangos ymagwedd bartneriaeth ragweithiol tuag at atal trosedd a gwneud buddsoddiad uniongyrchol yn iechyd a lles pobl ifainc y sir (Deddf Cenedlaethau'r Dyfodol) ac yn hwyluso ymgysylltiad heddlu a phartneriaid cadarnhaol â phobl ifainc, eu teuluoedd a'r gymuned ehangach.

Argymhellir cyfrannu £4,000 o'r gyllideb Deddf Elw Troseddau ynghyd â chymorth o £1,000 o gyllideb yr Heddlu.

**Title: Funding contribution to SCFC Kicks project Pembrokeshire**

**Category of Decision / Business Area Impact: Finance**

### Executive Summary:

Pembrokeshire BCU were approached by SCFC Premier League Kick's project, to develop the kicks project within Pembrokeshire in partnership with the OPCC and the Force. The project will bring the Premier League Kicks Project to Pembrokeshire, building on the success achieved in Seaside, Llanelli and across the Swansea City region. The project will provide children from the local area with a chance to be part of something meaningful - increasing their confidence, life chances and to act as a deterrent from crime & ASB through sport. It will demonstrate a proactive, partnership approach to crime prevention and make a direct investment in the health & wellbeing of young people in the county (Future Generations act) and will facilitate positive police and partner engagement with young people, their families and the wider community.

A contribution of £4k from POCA is recommended along with £1k support from the Forces budget.

### Recommendation:

To contribute £4k from the POCA budget towards the implementation of the Premier League Kicks project in Pembrokeshire.
