### **Crynodeb Gweithredol:**

Cychwynnodd Claire Parmenter y swydd Prif Gwnstabl Dros Dro ar 27 Chwefror 2021, gan dderbyn 90% o'r cyflog llawn, fel yr amlinellir yn rheoliadau'r heddlu. Noda'r rheoliadau hyn y gall CHTh gamu tu allan i'r trefniant hwn pe bai reswm ganddo dros wneud hynny.

Mae Claire wedi cyflawni'r swydd Prif Gwnstabl Dros Dro am gyfnod estynedig, a hynny yn ystod cyfnod heriol, â'r heddlu'n profi galw mawr digynsail yn ystod misoedd yr haf ynghyd â'r pwysau a ychwanegwyd gan COVID-19.

Yng ngoleuni hyn, mae'r Comisiynydd wedi penderfynu talu'r gyfradd ar y pryd i Claire, sef £146,469 y flwyddyn, a fydd yn cael ei hôl-ddyddio i 27 Chwefror 2021, pan gychwynnodd hi'r rôl. Daw'r taliad hwn i ben ar 23:59 ar 11 Rhagfyr 2021, pan fydd Richard Lewis yn cychwyn fel Prif Gwnstabl newydd Heddlu Dyfed-Powys, a bydd Claire yn dychwelyd i'w swydd barhaol fel Dirprwy Brif Gwnstabl.

## SUMMARY DECISION SHEET

**Purpose:** Commissioner Decision – Ref. DL 236

**Timing:** Routine

**Title:** CC remuneration

**Category of Decision / Business Area Impact:** Finance

### Executive Summary:

Claire Parmenter commenced the role of Temporary Chief Constable, on the 27th February 2021, receiving 90% of the full salary, as outlined in Police regulations. These regulations state that a PCC can step outside of this arrangement should they have reason to.

Claire has fulfilled the role of Temporary Chief Constable for an extended period, which has also been through challenging and testing times with the Force experiencing unprecedented high demands during the summer months this year along with added Covid-19 pressures.

In light of this, the Commissioner has decided to grant that Claire be paid the spot rate £146,469 per annum, which will be backdated from 27th February 2021, when she assumed the role. This payment will end at 23:59 on 11<sup>th</sup> December 2021, when Richard Lewis commences as the new Chief Constable of Dyfed-Powys Police, and Claire resumes her substantive position as Deputy Chief Constable.

### Recommendation:

That the PCC approves that Temporary Chief Constable Claire Parmenter be paid the spot rate of £146,469 per annum, backdated from 27<sup>th</sup> February 2021 to 11<sup>th</sup> December 2021.
