2020/2021

May – June 2020

Carmarthenshire Policing Hub and Custody Suite Development – Pre-application Consultation

The consultation provided those who may be interested in the development proposals with an opportunity to view the draft application package, express their views, and raise queries in relation to the proposed new development.

In addition to this, in May 2020, the Commissioner hosted a public meeting, held via video conferencing, providing residents and community representatives with the opportunity to raise questions around the development.

December 2020 – January 2021

‘Policing Priorities and Funding 2021/22 – Have your say’

In December 2020, Police and Crime Commissioner Dafydd Llywelyn, launched a public consultation to gather local residents’ and business owners’ opinions on two important policing matters:

- 1) What they believed Dyfed-Powys Police’s priorities ought to be, and
- 2) How much they would be willing to pay towards local policing, through the 2021/22 police precept (the amount paid towards policing through council tax).

January – February 2021

Young people’s experience of police contact

Focus groups were conducted with youth groups across the force area to gather young people’s views on, and experiences of police contact.

Through the focus groups, individuals were identified to be part of a video that the Commissioner’s Youth Forum was working on for Dyfed-Powys Police’s Learning and Development team.

Research through the Dyfed-Powys Victim Engagement Forum Engagement

During 2020/21, members of the Dyfed-Powys Victim Engagement Forum were asked to share their views on numerous policing and crime matters:

- 1) The content and layout of Dyfed-Powys Police’s Victim Information Pack.
- 2) The Restorative Justice process.
- 3) The impact of COVID-19 on support services and court services.

2021/2022

May – June 2021

Chief Constable appointment

This consultation asked residents and victims of crime to consider the attributes of a successful Chief Constable as part of the wider Chief Constable recruitment process.

May – June 2021

Police and Crime Plan consultation

Further to the 2020/21 consultation with residents and businesses via the annual precept questionnaire in December 2020, the Office of the Police and Crime Commissioner (OPCC) focused further consultation on 5 areas, which were:

- 1) Victims
- 2) Access
- 3) Prevention
- 4) Justice
- 5) Sustainability



This was a 3-tiered approach to consultation:

- 1) Facilitated sessions with 'lesser heard' groups;
- 2) Personal invitations / encouragement for special interest groups and partners;
- 3) General public communication / sharing.

October 2021 – November 2021

'Policing Priorities and Funding 2022/23 – Have your say'

In October 2021, Police and Crime Commissioner Dafydd Llywelyn, launched a public consultation to gather feedback from local residents, partners and business owners on two important policing matters:

- 1) The priorities set out within the Police and Crime Commissioner's 2021/25 Police and Crime Plan; and
- 2) The 2022/23 police precept.

November 2021 – December 2021

'Rural and Farm Crime in Wales'

This survey was the third in a biennial series of evaluations of the rural crime and policing initiatives developed across Dyfed-Powys; in addition to the regional examinations which have been published in 2017 and 2019, for the first time this year the survey was extended across all four police forces in Wales. Together with this wider focus beyond Dyfed-Powys, the current survey also targeted rural residents more generally – alongside the farming community – to ascertain their views on policing, crime and wider impacts from Covid and Brexit.

December 2021 - January 2022

'How safe do you feel in your local area?'

The term Violence Against Women and Girls (VAWG) refers to acts of violence or abuse which disproportionately affects women and girls, and VAWG came to the forefront of national discussions and media coverage during 2021. In response to this national coverage, it was important that the Police and Crime Commissioner considered the local situation. *Do women and girls feel disproportionately unsafe across the Force area?* To investigate this, the Commissioner launched a public consultation to assess general feelings of safety. The information gleaned through this consultation will allow us to identify any cause for concern locally in terms of feelings of safety, specifically within our female population.

Research through the Dyfed-Powys Victim Engagement Forum Engagement

During 2021/22, members of the Dyfed-Powys Victim Engagement Forum were asked to share their views on numerous policing and crime matters:

- 1) Proposed changes in how Dyfed-Powys Police deals with, and processes, non-emergency calls from victims of crime / incidents.
- 2) Victims' Personal Statements and a Personal Statement template.
- 3) The content and layout of Goleudy's leaflet detailing how the organisation supports victims and witnesses.

- 4) The content and layout of Dyfed-Powys Police's information and support guide for victims of rape and serious sexual assault.
- 5) The hours the Goleudy support service is available to victims and witnesses.
- 6) What is classed as an acceptable timeframe for a return call to a victim from Dyfed-Powys Police's Crime and Incident Hub.

There were no specific costs attributed to any of these surveys apart from

- The 2022/23 'Policing Priorities and Funding' survey' - Targeted Facebook promotion, at a cost of £29.68.
- Custody Suite Development – Pre-application Consultation' – Public consultation was conducted by Asbri Planning Consultants at a cost of £3,575
- 'Rural and Farm Crime in Wales' £8,880 to external organisation to conduct the research work on behalf of the OPCC
