**Executive Summary:** The Commissioner considered that a new OPCC website was required to accommodate - more fully than the existing site - the needs of the OPCC, its partners and the public. Innovations sought included: Improved two-way communication with the public, a victims' directory and a performance data component. A developer was sought to rebuild and improve the OPCC website. A competitive selection process was undertaken and the best proposal was deemed to come from Hinkford Ltd, Gwent.

**Recommendation:** The Commissioner is asked to approve the appointment of Hinkford Ltd as OPCC web developer.
