**Crynodeb Gweithredol:**

Cytunodd y Comisiynydd i rodd o £1000 tuag at yr Athro Matt Williams o Labordy Gwyddoniaeth Data Cymdeithasol ESRC i gydweithio â heddluoedd eraill ledled Cymru i gasglu gwybodaeth er mwyn llywio asesiadau tensiwn cymunedol mwy cywir a defnyddiol.

**Argymhelliad:**

Mae'r penderfyniad hwn yn ymwneud â chytundeb y PCC i roi £1000 ar gyfer ymchwil i asesiadau tensiwn cymunedol mwy cywir a defnyddiol ac i nodi ffordd gyson o fesur ac adrodd ar densiynau cymunedol gan ddefnyddio amrywiaeth o ffynonellau, gan gynnwys cysylltu â Llywodraeth Cymru.

Bydd yr ymchwil yn ystyried amrywiaeth o wybodaeth ar draws y pedwar llu yng Nghymru, gan gynnwys ystadegau troseddu, adroddiadau cymunedol gan wardeiniaid, galw am dai, ac eithafiaeth wleidyddol. Nod y prosiect yw gwerthuso cyfleustodau cyfathrebiadau cyfryngau cymdeithasol ar gyfer monitro tensiwn a chydlynid o fewn cymunedau lleol ledled Cymru, a gwerthuso rôl narratifau cyfryngau cymdeithasol cadarnhaol wrth dorri sbigiau mewn naratifau negyddol yn dilyn digwyddiad. Mae gweithio mewn partneriaeth yn hanfodol i gyflwyno dull cydgyssylltiedig o fynd i'r afael â'r heriau sy'n wynebu'r holl wasanaethau cyhoeddus yng Nghymru. Mae'r pedwar llu yng Nghymru wedi addo cefnogi'r prosiect.

**Title:** Donation for research into community tensions in Wales

**Category of Decision / Business Area Impact:**

**Executive Summary:**

Commissioner agreed to a donation of £1000 towards Prof Matt Williams from the ESRC Social Data Science Lab to collaborate with other police forces across Wales to gather intelligence to inform more accurate and usable community tension assessments.

**Recommendation:**

This decision relates to a £1000 donation for research to inform more accurate and usable community tension assessments. It seeks to identify a consistent way to measure and report on community tensions using a variety of sources, including linking into WG to inform their policy decisions. The research supports the strategy detailed in my Police and Crime Plan and will consider an array of intelligence across the four police forces in Wales, including crime statistics, community reports from wardens, demands for housing, and political extremism. It will aim to evaluate the utility of social media communications for tension and cohesion monitoring, and evaluate the role of positive social media narratives in curtailing spikes in negative narratives in the aftermath of an event. Partnership working is fundamental to delivering a joined-up approach to tackling the challenges that face all public services in Wales. All four police forces in Wales have pledged to support the project and have each donated £1000.
