**PURPOSE: COMMISSIONER DECISION - REF. DLI059**

**Timing: Urgent**

**Title: Refurbishment of Accommodation Block**

**Category of Decision / Business Area Impact: Finance/Training**

### **Executive Summary:**

A need for onsite provision of accommodation for staff attending training/conferences has been identified by the PCC/CC. Costing of a brand new building has been deemed to be outside current budgetary constraints and so the old Accommodation Block was identified as a source of fulfilling this need. This facility is in need of refurbishment and quotes obtained for this work estimate costs in the region of £99k. This will provide a 37-bed facility with communal bathrooms divided between male and female but in addition including a gender neutral provision. There will be a communal lounge with wifi provision at workstations but each room will also have a desk and chair. The DCC has liaised with UNISON and the Police Federation who are happy with the proposals.

**The Commissioner is asked to approve the works described above.**
