Crynodeb Gweithredol:

Disgwylir i Gomisiynydd yr Heddlu a Throseddu gynhyrchu adroddiad blynnyddol o'i weithgareddau yn erbyn blaenoriaethau ei Gynllun Heddlu a Throseddu a swyddogaethau statudol sydd wedi'u cyflenwi. Lluniwyd yr adroddiad gan staff SChTH yn y gorffennol, a'i argraffu gan y gwasanaeth heddlu, fodd bynnag, er mwyn cyflwyno cynyrrch proffesiynol mewn da bryd ar gyfer sioeau'r haf a digwyddiadau ymgysyltu, ceisir cymeradwyaeth i anfon yr adroddiad ar gyfer 2018/19 allan i'w gynllunio a'i argraffu.

Derbyniwyd amcanbrisiau gan bedwar cwmni. Mae'r cwmni a ddewiswyd wedi dangos y gall ddarparu'r gwasanaeth sydd angen am gost resymol, a bydd yn darparu'r hyblygrwydd sydd angen ar gyfer gwneud diwygiadau wrth i'r cynyrrch gael ei ddatblygu. Dim ond un cwmni a ddarparodd amcanbris ychydig yn is, fodd bynnag, byddai cost ychwanegol am bob diwygiad, ac nid oes modd rhagfynegi'r newidiadau hyn. Mae gallu'r cwmni a ddewiswyd i gyflwyno gwasanaeth dwyieithog hefyd yn bodloni anghenion y prosiect.

Title: Design company for Commissioner's 2018/19 Annual Report

Category of Decision / Business Area Impact: Governance / finance

Executive Summary:

The Police and Crime Commissioner is required to produce an annual report of his activities against his Police and Crime Plan priorities and delivery of statutory functions. The report has previously been designed by OPCC staff and printed by the police service, however in order to produce a professional product in time for distribution at summer shows and engagement events, approval is sought to outsource the design and printing for the 2018/19 report.

Quotes were received from four companies. The chosen company has demonstrated that they can provide the service required at a reasonable cost and will provide the required flexibility to make amendments throughout the development of the product. Only one company provided a slightly cheaper quote, however would add additional charges for each amendment, which could not be predicted. The chosen company's ability to provide a bilingual service also meets the needs of the project.

Recommendation:

To approve that the design of the Commissioner's 2018/19 Annual Report be undertaken by Celf Calon at a total cost of £1,000.
