### **Crynodeb Gweithredol:**

O ganlyniad i ddatblygiadau o ran y pandemig Coronafeirws presennol a chyngor a gyhoeddwyd gan y Llywodraeth, mae Heddlu Dyfed-Powys wedi penderfynu gohirio pob ymweliad nad yw'n hanfodol â safleoedd heddlu er mwyn amddiffyn cryfder yr heddlu yn Nyfed-Powys, ac yn arbennig gorsafoedd heddlu, sy'n safleoedd sensitif. Gan hynny, mae'r heddlu wedi penderfynu mai dim ond ymweliadau hanfodol â'r ddalffa y dylid eu cynnal er mwyn amddiffyn staff y ddalffa a'r amgylchedd dalffa.

O ganlyniad i'r penderfyniad uchod gan yr Heddlu, ein demograffeg ymwelwyr, ac mewn ymateb i nifer o ymwelwyr annibynnol â dalfeydd yn gofyn am gael dynnu'n ôl o'r cynllun hyd nes bod y sefyllfa o ran yr haint coronafeirws yn gwella, mae SCHTh wedi cytuno i ohirio pob ymweliad annibynnol â dalfeydd nes bydd hysbysiad pellach. Bydd ymweliadau'n ailgychwyn gyflym ag sy'n ymarferol bosibl.

Bydd SCHTh yn cadw mewn cysylltiad agos â'r dalfeydd ac yn ystyried ffyrdd eraill o oruchwylio gweithdrefnau dalffa yn ystod y cyfnod heriol hwn.

### **Argymhelliad:**

Cymeradwyo'r penderfyniad i atal ymweliadau annibynnol â dalfeydd nes bydd hysbysiad pellach tra bod y pandemig Coronafeirws yn parhau.

## SUMMARY DECISION SHEET

**Purpose:** Commissioner Decision – Ref.DLI169

**Timing:**

**Title: Independent Custody Visits suspended during Coronavirus pandemic**

**Category of Decision / Business Area Impact: Volunteer**

### Executive Summary:

As a result of developments with the current Coronavirus pandemic and advice issued from the Government, Dyfed-Powys Police have made the decision to postpone all non-essential visits to Police sites in order to safeguard the resilience of policing in Dyfed-Powys, and in particular the sensitive sites of Police Stations. The Force have therefore made the decision that only essential visits should be made to Custody in order to protect both the custody staff and custody environment.

As a result of the above Force decision, our Visitor demographics, and in response to a number of our Independent Custody Visitors (ICVs) asking to withdraw themselves from ICV visits until the current situation with coronavirus eases, the OPCC has agreed to suspend all ICV visits until further notice. Visits will re-commence as soon as practically possible.

The OPCC will remain in close contact with custody and will consider alternative ways of maintaining an oversight of custody procedures during this challenging time.

### Recommendation:

To approve the decision that ICV visits will be suspended until further notice whilst the Coronavirus pandemic is ongoing.
